On Amendments to the Procedure of Fee Payment for Actions Related to the Protection of Intellectual Property Rights

The Cabinet of Ministers of Ukraine hereby resolves:

1. To amend the <u>Procedure of Fee Payment for Actions Related to the Protection of Intellectual</u> <u>Property Rights</u>, approved by Resolution No. 1716 of the Cabinet of Ministers of Ukraine of 23 December 2004 (Official Bulletin of Ukraine, 2004, No. 51 3354; 2019, No. 49, Article 1666; 2021, No. 3, Article 160), as follows.

2. This Resolution shall enter into force within 30 days from the date of its publication.

AMENDMENTS

to the <u>Procedure of Fee Payment for Actions Related to the Protection of Intellectual</u> <u>Property Rights</u>

1. <u>Paragraphs 3</u>, 3¹, 3² and 3⁴ shall be amended to read as follows:

"3. An individual who is an applicant, holder of a relevant patent or a certificate of state registration of an industrial design or a certificate of registration of a semiconductor product layout shall pay a respective fee for actions related to the protection of such rights, except for fees under the codes 13300, 13400, 13700, 22200, 22400, 32100 and 32300 in accordance with the Annex - in the amount of:

10 per cent of the established fee provided by the Annex - if mentioned individuals are the inventors of an invention or the authors of a semiconductor product layout;

20 per cent of the established fee under the Annex - if mentioned individuals are the inventors of a utility model or the authors of an industrial design.

3¹ Non-profit institutions and organisations that are applicants or holders of a patent for an invention (utility model) shall pay a respective fee for actions related to the protection of such rights, except for fees under the codes 13300, 13400, 13500 and 13700 in accordance with the Annex - in the amount of:

12 per cent of the established fee under the Annex - if the mentioned persons are applicants who file an application for an invention or holders of a relevant patent;

30 per cent of the established fee under the Annex - if the mentioned persons are applicants who file a utility model application or holders of a relevant patent.

In case of a subsequent transfer of rights within five years from the date of state registration of an invention (utility model), industrial design or semiconductor product layout to a person towards whom the fee reduction provided by paragraphs 3, 3¹ and 3² of this Procedure is not applied, or including such person into the list of holders of the respective patent or certificate, such transfer or inclusion shall be subject to an additional fee paid for the last three years preceding the transfer or inclusion, up to the full amount, established under the Annex."

2. <u>The Procedure</u> shall be supplemented with paragraph 3⁵ to read as follows:

"3⁵. If an application for an intellectual property rights is filed in electronic form, the amount of fees under the codes:

10100, 20100, 30100 and 50100 in accordance with the Annex shall amount to 80 per cent of the fee amount established under the relevant code;

40100 or 40200 in accordance with the Annex shall amount to 75 per cent of the fee established by the relevant code.

The fee amount for filing an application for intellectual property rights in electronic form shall be determined by the fee amount to which the basis to reduce/increase its amount is applied."
